## WHAT IS THIS PRODUCT?

**Type**: Ruth Core Nordic Credit is a sub-fund of Ruth Asset Management SICAV, a public limited company incorporated as an investment company with variable share capital and subject to part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment.

**Term**: The sub-fund has no maturity date. However, please note that the sub- fund may be closed if it is in the interest of the shareholders and endorsed by the board of the fund in accordance with specific conditions or circumstances as described in the fund prospectus.

**Objective**: Ruth Core Nordic Credit is an actively managed bond fund whose objective is to outperform its benchmark index. The sub-fund's benchmark index is the Solactive SEK IG Credit Index. The management company assesses that the benchmark index aligns with the sub-fund's investment focus regarding its asset type (corporate bonds). The sub-fund has a sustainability focus, meaning that the sub-fund's assets are only invested in bonds issued by companies with high sustainability ratings. The sub-fund makes sustainable investments and is categorized as Article 9 in accordance with the EU Disclosure Regulation (SFDR). The sub-fund applies the management company's sustainability guidelines, which are available at www.ruthassetmanagement.com.

**Intended Retail Investor**: This fund may be suitable for investors who plan to hold their investment for at least 3 years and who understand that the money invested in the fund may both increase and decrease in value and that it is not certain that the entire capital invested can be returned. Investing in the Fund does not require any specific prior knowledge or experience of UCITS or financial markets.

# Performance scenarios

#### WHAT HAPPENS IF RUTH ASSET MANAGEMENT SICAV IS UNABLE TO PAY OUT?

Each fund must have a dedicated depositary to take care of the safekeeping of the sub-fund's assets. There is a potential default risk if the assets of the sub-fund held with the depositary are lost. However, such default risk is limited due to the segregation of assets between those of the depositary and the sub-fund. The depositary is liable to the sub-fund or to the investors of the sub-fund for the loss by the depositary or one of its delegates of a financial instrument held in custody unless the depositary can prove that the loss has arisen as a result of an external event beyond its reasonable control. For all other losses, the depositary is liable in case of its negligent or intention failure to properly fulfil its obligations pursuant to the Luxembourg law of 17 December 2010 relating to undertakings for collective investment. There is no other compensation or guarantee scheme for investors in the sub-fund.

# WHAT ARE THE COSTS?

The person advising you on or selling the product may charge additional fees. If that is the case, they must inform you about these costs and how they affect your investment. If the sub-fund is included as part of another product, for example an investment insurance, other fees may apply for that product.

**Costs over time** The tables show the amounts taken from your investment to cover various types of costs. The amounts depend on how much you invest, how long you hold the product, and how the product performs. The amounts shown here are based on an example investment amount and various possible investment periods.

We have assumed the following:

- In the first year, you get back the amount you invested (0% annual return). For year 3, we have assumed that the product performs as shown in the neutral scenario.
- 100,000 SEK is invested.

# HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

#### **Recommended holding period: 3 years**

The sub-fund has no minimum holding period requirement and is suitable for a medium-term investment horizon. You should be prepared to hold the sub-fund for at least 3 years. You can generally sell your fund shares on any business day without any additional fee.
